

## **Bare Opera Privacy Policy**

Bare Opera, Inc. (the “Company,” “we” or “our”) is committed to protecting your privacy online. Use of the Company’s website at [www.bareopera.org](http://www.bareopera.org) (the “Site”), including all materials presented herein and all online services provided by the Company, is subject to the following privacy policy (the “Privacy Policy”). The Privacy Policy applies to all site visitors, customers, and all other users of the site. This Privacy Policy explains how we collect and use the personal information we obtain from you through our Site. The term “personal information” means information that you voluntarily provide to us which personally identifies you and/or your contact information, such as your name, phone number and email address. The term “user,” “you” and “your” refers to site visitors, customers and any other users of the Site.

### **INFORMATION YOU PROVIDE TO US**

**Form Submission.** When you submit a “Contact Us” form, we may collect your name and email address, along with any other information you choose to provide.

**Subscriptions.** When you use the “Subscribe” feature to sign up for our newsletter, we may collect your email address.

**Communications.** If you contact us directly, we will receive your name, email address, the contents of the message, any attachments you may send to us, and any other information you choose to provide.

**Purchase of Tickets.** When you click on a link to purchase tickets, you will be redirected to a third-party partner’s website, which handles the sale of our tickets. This third-party website may collect various information from you, including your name, email, credit card information and address. We have no control over the information that the third-part website requests in order to enable you to purchase tickets, or what the third-party website does with the information that you provide.

### **INFORMATION WE COLLECT WHEN YOU USE THE SITE**

**Information from Cookies and Similar Technologies.** We and third-party partners collect information using cookies, pixels, and similar technologies. Our third-party partners, such as analytics partners, may use these technologies to collect information about your online activities over time and across different websites and online services. Cookies are small text files that contain a string of alphanumeric characters. We may use both session cookies and persistent cookies. A

session cookie disappears after you close your browser. A persistent cookie remains after you close your browser and may be used by your browser on subsequent visits to our Site. Please review your web browser's "Help" file to learn how to modify your cookie settings. Please note that if you delete or choose not to accept cookies from our Site, you may not be able to utilize it to its fullest potential.

**Device Information.** We automatically collect certain technical information about the device and software you use to access our Site, including your IP address, operating system version, web browser type, phone carrier and manufacturer, application installations and usage, device identifiers, mobile advertising identifiers, and push notification tokens.

**Usage Information.** To help us understand how you use our Site and to help us improve them, we automatically receive information about your interactions with our Site, such as the pages you visit or content you view, the searches you conduct, and the dates and times of your visit.

## HOW WE USE THE INFORMATION WE COLLECT

We use the information we collect:

- To provide, maintain, improve, and enhance our services;
- To understand and analyze how you use our services and develop new products, services, features, and functionality;
- To communicate with you, provide you with updates and other information relating to the site, provide you with information that you request, respond to comments and questions, and otherwise provide customer support;
- For marketing purposes, such as developing and providing promotional materials that may be relevant, valuable, or otherwise of interest to you;
- To find and prevent fraud and respond to trust and safety issues that may arise;
- For compliance purposes, including enforcing our legal rights or as may be required by applicable laws and regulations or requested by any judicial process or governmental agency; and
- For other purposes for which we provide specific notice at the time the information is collected.

## HOW WE SHARE THE INFORMATION WE COLLECT

**Vendors and Service Providers.** We may share your information with trusted third parties who assist us in operating our Site, conducting our business and servicing clients and

visitors. These trusted third parties agree to keep this information confidential. Your personal information will never be shared with or sold to unrelated third parties.

**Analytics Partners.** We use analytics services such as Google Analytics to collect and process certain analytics data. These services may also collect information regarding your use of other websites, apps, and online resources. **As Required by Law and Similar Disclosures.** We may access, preserve, and disclose your information if we believe doing so is required or appropriate to: (a) comply with law enforcement requests and legal process, such as a court order or subpoena; (b) respond to your requests; or (c) protect your, our, or others' rights, property, or safety.

**Merger, Sale, or Other Asset Transfers.** We may transfer your information to service providers, advisors, potential transactional partners, or other third parties in connection with the consideration, negotiation, or completion of a corporate transaction in which we are acquired by or merged with another company or we sell, liquidate, or transfer all or a portion of our assets. The use of your information following any of these events will be governed by the provisions of this Privacy Policy in effect at the time the applicable information was collected.

**Consent.** We may also disclose your information with your permission.
